# GENERAL ENTRY

## **Australian School Leavers**

Entry into the Bachelor of Business (Accounting) requires completion of the NSW Higher School Certificate (HSC) or an equivalent qualification with a minimum Band 2 in English Standard or English EAL/D and a Band 2 in Mathematics Standard 2 or in one of the following approved quantitative subjects: Business Studies, Economics, Financial Studies, or an equivalent approved subject.

Applicants whose first language is not English must meet Gateway Business College's English language requirements as outlined in Language Requirement section below.

Alternative admission arrangement: Completion of at least one year of an approved tertiary qualification equivalent to AQF Level 5 or higher.

## **International Students / Students Completing Secondary School Overseas**

International applicants must demonstrate successful completion of a qualification equivalent to the NSW HSC, with passing grades in Mathematics or an appropriate quantitative subject such as Business Studies, Economics, Financial Studies, or an equivalent approved subject.

Applicants whose first language is not English must meet Gateway Business College's English language requirements as outlined in Language Requirement section below.

Alternative admission arrangement: Completion of at least one year of an approved tertiary qualification equivalent to AQF Level 5 or higher.

## **Special and/or Alternative Entry: Non-School Leavers**

Applicants without a formal qualification but with appropriate years of relevant work experience will be considered.

Applicants whose first language is not English must meet Gateway Business College's English language requirements as outlined in Language Requirement section below.

Alternative admission arrangement: Skills and knowledge gained through work, life experience, and/or formal training are assessed on a case-by-case basis.

# LANGUAGE REQUIREMENTS

No more than two (2) years prior to course commencement.

English language test results must be dated no more than two (2) years prior to the date of application. (Reworded statement, choose one option that aligns closer with requirement)

## **International Applicants**

Applicants must provide evidence of meeting one of the following:

Recognised English Language Tests for Bachelor Degree

- IELTS Academic: Overall 6.0, no band less than 6.0
- PTE Academic: Overall 52, no communicative score less than 52
- TOEFL Internet Based Test: Listening 16, Reading 16, Speaking 18, Writing 21, Overall 67
- Cambridge CAE: Overall score 169, no component less than 169
- Australian Qualification: AQF Level 5 (Diploma or higher)

### **Prior Study in English**

- At least one year of full-time study in a formal qualification delivered and assessed in English at:
  - o AQF Level 5 or higher (Bachelor applicants)

Applicants who completed their study more than two years before beginning their course of study at Gateway Business College may still meet English language proficiency requirements if they meet both of the following requirements:

- The applicant has successfully completed (with assessment) a post-secondary qualification that lasted at least three years full time. The instruction and assessment must have been in English.
- The applicant has lived since graduation in Australia or another country where English is the most commonly spoken language. In this case, proof of residency is required at the time of application.

All cases where an applicant has had prior study in English will be evaluated individually. Meeting the above criteria does not guarantee the applicant will meet the English language proficiency criteria.

### **Citizenship**

Applicants will meet the requisite English language requirements if they are citizens of one of the countries listed below and have undertaken:

- Formal secondary or tertiary study of English in the national education system of that country
- Formal study of English at a university recognised by Gateway Business College in that country.

Australia, Botswana, Canada, Fiji, Guyana, Ireland, Jamaica, Kenya, Lesotho, Liberia, Malaysia, New Zealand, Nigeria, Papua New Guinea, Philippines, Samoa, Singapore, Solomon Islands, South Africa, Trinidad & Tobago, United Kingdom, United States of America, Zambia, Zimbabwe, China.
